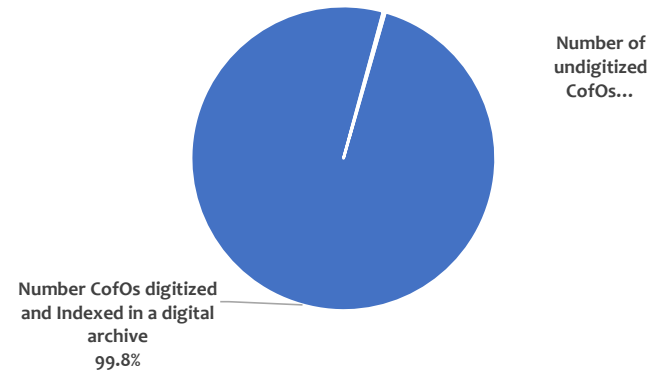

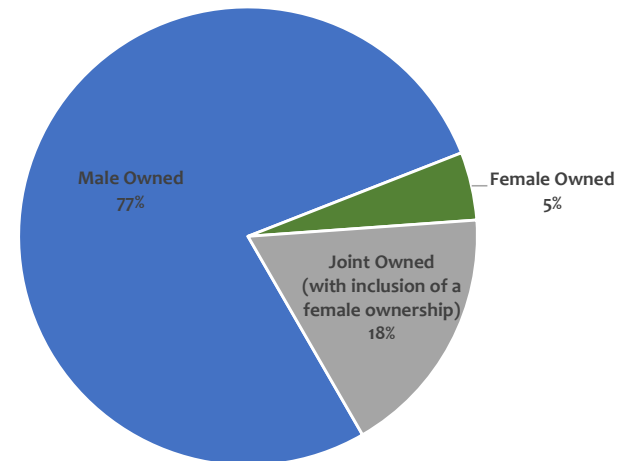

December 2021)

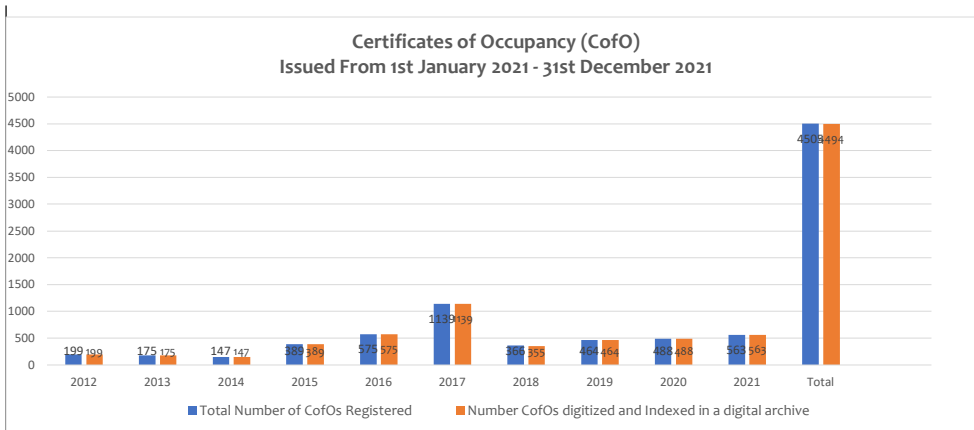
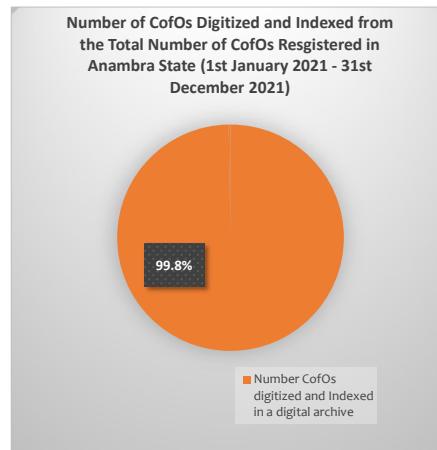


Gender spread of **Anambra State CofOs**  
(CofOs Issued between 1st January 2021 - 31st December 2021)



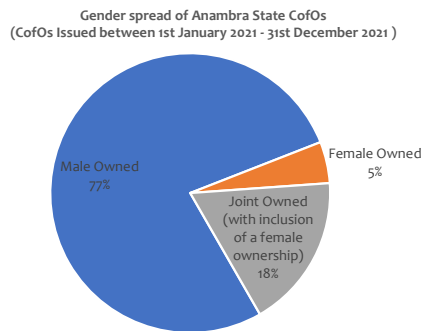
