A revised Law to provide for the sum of N 114, 971, 261, 220.76 (One Hundred and Fourteen Billion, Nine Hundred and Seventy-one Million, Two Hundred and Sixty-one Thousand, Two Hundred and Twenty Naira, Seventy-six Kobo) for services of the Government of Anambra State of Nigeria for the year ending Thirty First December, 2020, and for related purposes.

Whereas it is deemed necessary that certain sums be appropriated for the services of Anambra State of Nigeria for the year ending on 31<sup>st</sup>day of December, 2020, to be applied as described in this Law and for the services set forth in the Schedule to this Law;

Now, therefore, the Anambra State House of Assembly ENACTS as follows -

Short title and Commencement.

 This Law may be cited as the Anambra State of Nigeria Revised 2020 COVID-19 Response Multi-Year Appropriation Law and shall be deemed to come into force on the 27<sup>th</sup> day of July, 2020.

Issue of N49,164,463,958.47

No issue of funds after 31<sup>st</sup> December, 2020. 6. No part of the sum mentioned in Sections 2 and 4 of this Law shall be issued out of the Consolidated Revenue Fund or the Capital Development Fund of Anambra State after 31<sup>st</sup> December, 2020.

Release of funds 7. for implementation.

The Commissioner for Finance shall ensure that the Funds appropriated under this Law are released to the appropriate Ministries, Departments and Agencies (MDAs) of Government as and when requested.

Virement.

8. In the event that the implementation of any of the projects intended to be undertaken under this Law cannot be completed without Virement, such Virement shall only be effected with the prior approval of the House of Assembly.

Repeal of earlier Appropriation Law, 2020.  The earlier Anambra State Appropriation Law of 1<sup>st</sup> January, 2020 is repealed.
